- 4 The Contractor need to furnish the documents for ownership of fthe construction equipments required for the construction of highrise buildings.*
- 5 Permanent Account Number (PAN) & GST Certificate of the contractor should be furnished in the tender.*
- 6 The contractor shall be liable to pay all the existing and future statutory taxes.*
- 7 The contractor shall be personally present for negotiation, if any ,and signing of agreement. No negotiation and signing of agreement will be done in the absence of contractor.*
- 8 The contractor will bring his/her latest passport size photograph at the time of signing agreement*
