- 5 . The contractor will bring his/her latest passport size photograph at the time of signing agreement.*
- 6 . Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.*
- 7 . The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.*
- 8 . The contractor shall be submit the copy of uploaded documents by post before opening tender.*
- 9 . The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.*
