

Tenders/Bids, E.M.D and cost of tender form shall be accepted through online mode only and no manual submission of the same shall be entertained. The tender documents of the work can be downloaded the site from **01.07.2024 at 2.30PM**.

NB:- 1. Tendering process will be 2 cover system (Financial bid, Technical bid)

- 2 Only those Contractors who qualified for Technical bid will be considered for Financial bid opening.
- 3 Contractors shall invariably produce documentary evidence for completing similar single work costing 80% or two similar works each costing not less than 60% of cost of the work proposed within last 5 years .
- 4 The Contractor need to furnish the documents for ownership of fthe construction equipments required for the construction of highrise buildings.
- 5 Permanent Account Number (PAN) & GST Certificate of the contractor should be furnished in the tender.
- 6 The contractor shall be liable to pay all the existing and future statutory taxes.
- 7 The contractor shall be personally present for negotiation, if any ,and signing of agreement. No negotiation and signing of agreement will be done in the absence of contractor.
- 8 The contractor will bring his/her latest passport size photograph at the time of signing agreement.
- 9 Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.
- 10 The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.
- 11 The contractor shall be submit the copy of uploaded documents by post before opening tender.
The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.
The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.
