*4 The Contractor need to furnish the documents for ownership of the construction equipments required for the construction of highrise buildings.*

*5 Permanent Account Number (PAN) and GST certificate of the contractor should be furnished in the tender.*

*6 The contractor shall be liable to pay all the existing and future statutory taxes.*

*7 The contractor shall be personally present for negotiation, if any ,and signing of agreement. No negotiation and signing of agreement will be done in the absence of contractor.*

*8 The contractor will bring his/her latest passport size photograph at the time of signing agreement.*

*9 Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.*

*10 The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.*

*11 The contractor shall be submit the copy of uploaded documents by post before opening tender.*

*12 The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.*

*13 The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.*

*14 The tender authority has all the rights to reject a tender if it doesn't meet the tender conditions and also if it doesnot contain any valid documents as demanded in the cover.*

*15 Contractors are allowed to use only materials of approved brand for both civil, plumbing and electrical works as detailed in the perma included in the technical cover.*
