- 2 Only those Contractors who qualified for Technical bid will be considered for Financial bid opening.*
- 3 Contractors shall invariably produce documentary evidence for completing one or similar work costing 40% of estimated cost of work proposed within last 5 years .*
- 4 The Contractor need to furnish the documents for ownership of fthe construction equipments required for the construction of highrise buildings.*
- 5 Permanent Account Number (PAN) of the contractor should be furnished in the tender.*
- 6 The contractor shall be liable to pay all the existing and future statutory taxes.*
- 7 The contractor shall be personally present for negotiation, if any ,and signing of agreement. No negotiation and signing of agreement will be done in the absence of contractor.*
- 8 The contractor will bring his/her latest passport size photograph at the time of signing agreement.*
- 9 Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.*
