6 The MD, KPHCC reserves the right to reject any quotation without assigning any reason what so ever.

7 The defect liability provision for the quality of materials and workmanship shall be as per G.O.(P).No.161/2019/Fin, dated-25.11.2019

8 The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.

9 The quotation inviting authority has all the rights to reject a quotation if it doesn't meet the quotation conditions and also if it does not contain any valid documents as demanded in the cover.
