6. *Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.*

8. *The contractor shall be submit the copy of uploaded documents by post before opening tender.*
9. *The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.*
