 - The contractor will bring his/her latest passport size photograph at the time of signing agreement.
 - Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.

 - EMD /SD/APG exemption of MSME Contractor not allowed.
 - The contractor shall submit the copy of uploaded documents by post before opening tender.
