- 5 The contractor will bring his/her latest passport size photograph at the time of signing agreement.
- 6 Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.
- 7 The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.
- 8 EMD /SD/APG exemption of MSME Contractor not allowed.
- 9 The contractor shall be submit the copy of uploaded documents by post before opening tender.
- 10 The defect liability provision for the quality of materials and workmanship shall be as per G.O.(P). No. 161/2019/Fin dtd 25-11-2019
- 11 The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.
- 12 The tender authority has all the rights to reject a tender if it doesn't meet the tender conditions and also if it does not contain any valid documents as demanded in the cover.
