8 No EMD and tender fee exemption is allowed on submission of tender for MSME registered firms.

9 The contractor shall submit the copy of uploaded documents by post before opening tender.

10 The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.
