  - 6 . Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.
  - 7 . The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.
  - 8 . The contractor shall be submit the copy of uploaded documents by post before opening tender.
  - 9 . The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.
  - 10 . The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.
  - 11 . The tender authority has all the rights to reject a tender if it doesn't meet the tender conditions and also if it doesnot contain any valid documents as demanded in the cover.
