Permanent Account Number (PAN) and GST certificate of the contractor should be furnished in the tender.

2 The contractor shall be liable to pay all the existing and future statutory taxes.

3 The contractor shall be personally present for negotiation, if any ,and signing of agreement. No negotiation and signing of agreement will be done in the absence of contractor.

4 The contractor will bring his/her latest passport size photograph at the time of signing agreement.

5 Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.

6 The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.

7 No EMD and tender fee exemption is allowed on submission of tender for MSME registered firms.

8 The contractor shall submit the copy of uploaded documents by post before opening tender.

9 The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.

10 The payment of works will be released only through concerned departments as per

11 GO.(P).No.118/2018/Fin dated 03.08.2018.

12 The tender authority has all the rights to reject a tender if it doesn't meet the tender conditions and also if it doesnot contain any valid documents as demanded in the cover.
