- 7 The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.*
- 8 EMD /SD/APG exemption of MSME Contractor not allowed.*
- 9 The contractor shall be submit the copy of uploaded documents by post before opening tender.*
- 10 The defect liability provision for the quality of materials and workmanship shall be as per G.O.(P). No. 161/2019/Fin dtd 25-11-2019*
- 11 The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.*
