

  4. The contractor shall be personally present for negotiation, if any ,and signing of agreement. No negotiation and signing of agreement will be done in the absence of contractor.
  4. The contractor will bring his/her latest passport size photograph at the time of signing agreement.
  - 6 Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.
  - 7 The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.
  8. EMD/SD/APG exemption of MSME Contractors not allowed.
  - 9 . The contractor shall be submit the copy of uploaded documents by post before opening tender.
