- 2. Permanent Account Number (PAN) & GST certificate of the contractor should be furnished in the tender.*
 - 3. The contractor shall be liable to pay all the existing and future statutory taxes.*
 - 4. The contractor shall be personally present for negotiation, if any ,and signing of agreement. No negotiation and signing of agreement will be done in the absence of contractor.*
 - 5. The contractor will bring his/her latest passport size photograph at the time of signing agreement.*
 - 6. Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.*
 - 7. The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.*
 - 8. The contractor shall be submit the copy of uploaded documents by post before opening tender.*
 - 9. The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.*
 - 10. The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.*
 - 11. The tender authority has all the rights to reject a tender if it doesn't meet the tender conditions and also if it doesnot contain any valid documents as demanded in the cover.*
 - 12. No EMD and Tender fee exemption is allowed on submission of tenders for MSME registered firms.*
