*5 The contractor will bring his/her latest passport size photograph at the time of signing agreement.*

*6 Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.*

*7 The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.*

*8 No EMD and tender fee exemption is allowed on submission of tender for MSME registered firms.*

*9 The contractor shall submit the copy of uploaded documents by post before opening tender.*

*10 The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.*

*11 The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.*
