

 - 4 The contractor shall be personally present for negotiation, if any ,and signing of agreement. No negotiation and signing-of-agreement will be done in the absence of contractor.
 - 5 The contractor will bring his/her latest passport size photograph at the time of signing agreement.
 - 6 Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.
 - 7 The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.
 - 8 EMD /SD/APG exemption of MSME Contractor not allowed.
 - 9 The contractor shall be submit the copy of uploaded documents by post before opening tender.
 - 10 The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.
