- 3 Contractors shall invariably produce documentary evidence for completing similar single work costing 80% or two similar works each costing not less than 60% of cost of the work proposed within last 5 years .*
- 4 The Contractor need to furnish the documents for ownership of the construction equipments required for the construction of highrise buildings.*
- 5 Permanent Account Number (PAN) and GST certificate of the contractor should be furnished in the tender.*
- 6 The contractor shall be liable to pay all the existing and future statutory taxes.*
- 7 The contractor shall be personally present for negotiation, if any ,and signing of agreement. No negotiation and signing of agreement will be done in the absence of contractor.*
- 8 The contractor will bring his/her latest passport size photograph at the time of signing agreement.*
- 9 Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.*
- 10 The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.*
- 11 The contractor shall be submit the copy of uploaded documents by post before opening tender.*
- 12 The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.*
- 13 The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.*
- 14 The tender authority has all the rights to reject a tender if it doesn `t meet the tender conditions and also if it doesnot contain any valid documents as demanded in the cover.*
