5 The contractor will bring his/her latest passport size photograph at the time of signing agreement.

6 The MD, KPHCC reserves the right to reject any quotation without assigning any reason what so ever.


7 The defect liability provision for the quality of materials and workmanship shall be as per G.O.(P).No.161/2019/Fin, dated-25.11.2019
