4. *The contractor shall be personally present for negotiation, if any, and signing of agreement. No negotiation and signing of agreement will be done in the absence of contractor.*
5. *The contractor will bring his/her latest passport size photograph at the time of signing agreement.*
6. *Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.*
7. *The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.*
8. *The contractor shall be submit the copy of uploaded documents by post before opening tender.*
9. *The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.*
10. *The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.*
11. *The tender authority has all the rights to reject a tender if it doesn't meet the tender conditions and also if it doesnot contain any valid documents as demanded in the cover.*
