  - 6 Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.
  - 7 The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.
  - 8 EMD /SD/APG exemption of MSME Contractor not allowed.
  - 9 The contractor shall be submit the copy of uploaded documents by post before opening tender.
  - 10 The defect liability provision for the quality of materials and workmanship shall be as per G.O.(P).No.161/2019/Fin, dated-25.11.2019
