  - The contractor shall be liable to pay all the existing and future statutory taxes.
  - The contractor shall be personally present for negotiation, if any ,and signing of agreement. No negotiation and signing of agreement will be done in the absence of contractor.
  - The contractor will bring his/her latest passport size photograph at the time of signing agreement.
  - Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.
  - The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.
  - EMD /SD/APG exemption of MSME Contractor not allowed.
  - The contractor shall be submit the copy of uploaded documents by post before opening tender.
  - The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.
  - The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.
