 - 2 Permanent Account Number (PAN) and GST certificate of the contractor should be furnished in the tender.
 - 3 The contractor shall be liable to pay all the existing and future statutory taxes.
 - 4 The contractor shall be personally present for negotiation, if any, and signing of agreement. No negotiation and signing of agreement will be done in the absence of contractor.
 - 5 The contractor will bring his/her latest passport size photograph at the time of signing agreement.
 - 6 Proxy tenders will not be accepted. Such proxy tenderers will also be liable to criminal action and cancellation of the work awarded to them.
 - 7 The MD, KPHCC reserves the right to reject any tender without assigning any reason what so ever.
 - 8 No EMD and tender fee exemption is allowed on submission of tender for MSME registered firms.
 - 9 The contractor shall submit the copy of uploaded documents by post before opening tender.
 - 10 The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.
 - 11 The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.
 - 12 The tender authority has all the rights to reject a tender if it doesn't meet the tender conditions and also if it doesnot contain any valid documents as demanded in the cover.
