8 EMD /SD/APG exemption of MSME Contractor not allowed.

9 The contractor shall be submit the copy of uploaded documents by post before opening tender.

10 The defect liability provision for the quality of materials and workmanship shall be as per G.O.(P). No. 161/2019/Fin dt 25-11-2019

11 The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.
