8 No EMD and tender fee exemption is allowed on submission of tender for MSME registered firms.

9 The contractor shall submit the copy of uploaded documents by post before opening tender.

10 The defect liability provision for the quality of materials and workmanship shall be 5 years for original works after the completion of the entire project or identified phases of the project.

11 The payment of works will be released only through concerned departments as per GO.(P).No.118/2018/Fin dated 03.08.2018.
